Application:

Attention: The surfaces to be sealed have to be dry, free from frost, grease and silicone as well as abrasion-proof. If tape should be applied on wood, take care that wood is dry and that no resin is flowing out of it. Don't coat the tape with paint, MS-polymer or other solvent containing materials. Don't use aggressive gaseous chemicals like solvents of paint, acids or MS-polymer next to the tape during or after application process. The tape is cold self-adhesive, don't heat it during or after application process with or without an open flame. The tape adheres only on some type of PVC-surfaces. Try stickiness with a small amount before application. Walkable or rolled subsoil are not suitable for the application.

The best application temperature range is between 5 °C and 40 °C air or surface temperature. At colder temperatures the tape should be stored before application at room temperature if possible. Additional a special primer is recommended (approx. 200 ml/ m₂). The same primer should be used in case of porous or dusty subsoil to achieve an optimum adhesion.

Tytan professional RS Tapehas to be pressed on firmly after the application. The appearance of cavities (blisters) has to be avoided. If several tapes will be applied the overlapping has to be at least 50 mm.
